

Terms and Conditions

1. The Lucky Draw is open to all valid SAFRA members (“Participants”), except the employees and volunteers of SAFRA and their immediate family members.
2. The Lucky Draw Period shall run from 1 Jan to 31 Jan 2020 (both dates inclusive).
3. The mechanics of the Lucky Draw are as follows:
 - a) A lucky draw chance or coupon shall be issued to a SAFRA Member who has a valid and original receipt of \$20.20 minimum spend, in a single receipt, at any participating vendor at SAFRA Mount Faber. (Please refer to point 7 for list). Combination of receipts is strictly disallowed.
